

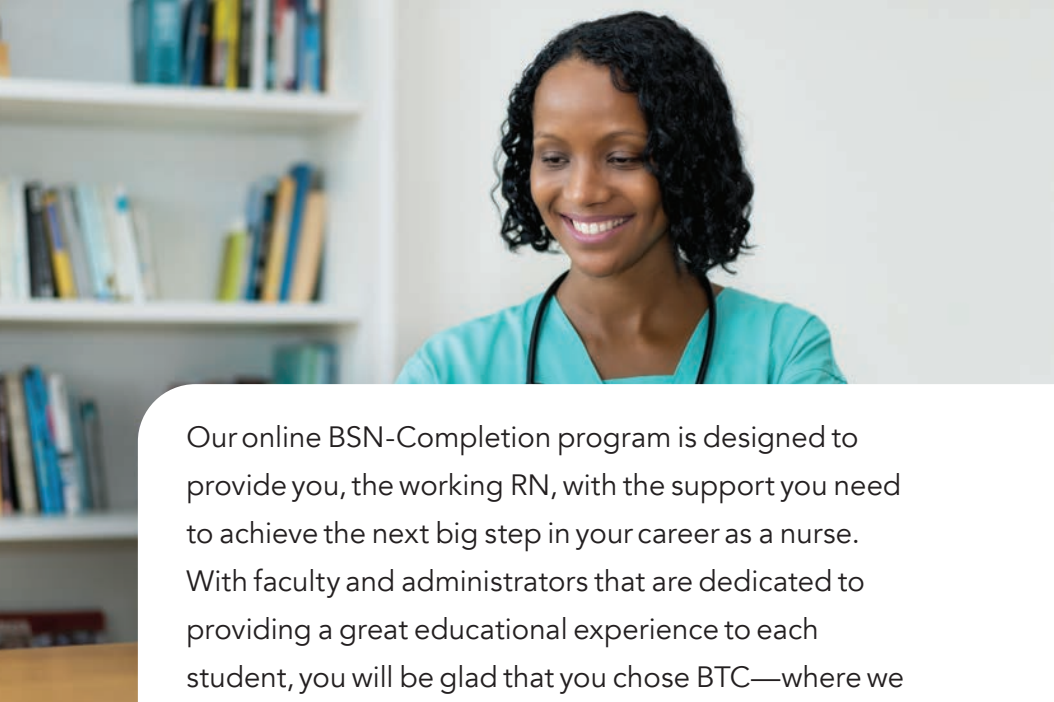

Students may complete the program in as little as 1 year. All courses must be completed within 3 years of admission for part-time plans of study.

Students are required to complete all core nursing courses within this program.

*Students are awarded up to 73 credits for advanced placement in the BSN completion program. This is a combination of transfer credit and licensure credit. 19 credits are awarded for completion of required pre-requisite courses: A&P I (4 credits), A&P II (4 credits), Microbiology (4 credits), Chemistry (4 credits), Nutrition (3 credits). A&P, microbiology, and chemistry require a lab component for transfer. 54 credits are awarded for licensure as a Registered Nurse.

Courses are divided in each semester as 7 or 8 week blocks. Total semester time is 15 or 16 weeks.
